  - Mr. Mireles mentioned that the City of Brawley will be working with Republic Services to gather the information needed from them.

- Ms. Larner introduced Chelsea Callaham as the new local assistant development in market representative for the Imperial County Region. Ms. Callaham will be working with all the cities in the county. Ms. Callaham will be reaching each jurisdiction and will be helping Ms. Galarza with the EAR report.

4. IVRMA Updates.

Ms. Delgadillo provided the following updates.

- IVRMA has partnered with certified used oil collection centers like AutoZone, and O'Reilly's to provide oil containers every month to their facility for residents to pick up when needed at no cost.
- The staff has 4 June community events planned; 2 in the City of Calipatria, and 2 in the City of El Centro.
- IVRMA partnered with one of their vendors SES along with CR&R to collaborate for the cleanup events/ IVRMA events to expand on items received during the events. IVRMA will be receiving any items that are normally accepted at the HHW facilities. IVRMA will be focusing on scheduling events for remote and unincorporated areas in Imperial County during the fall of 2023.
