- 2. April 25, MINUTES were reviewed, and no comments or changes were requested. Minutes were adopted for April 25, 2024. (Campos, seconded by Castañeda) **Motion Carried.**

3. CALRECYCLE LAMD

Ms. Larner provided the following updates.

- The capacity planning for the next cycle of 10 year planning period will be from January 1, 2025-2034.
- CalRecycle held an SB1383 webinar chat on May 13, 2024. The topic was Enforcement 3 jurisdictions shared their processes for Enforcement. The chat was recorded and will be available on the CalRecycle YouTube channel. Another SB1383 chat will happen in late June and will be focused on implementation records.
- CalRecycle has the I Recycle Smart campaign tools available for local jurisdictions to utilize. It has videos, audio, social media, print assets, and advertisements that could go in grocery

- carts and buses. Ms. Larner will send the updates to Ms. Galarza so she can forward them to all jurisdictions and have the links.
- On May 23, 2024, in the afternoon there will be a workshop on the Recycling and Disposal reporting system. There have been some changes in the Recycling and Disposal reporting system and there will be a webinar from 1:00 pm to 4:00 pm on May 23, 2024.
- On June 19&20 the California tire conference will take place in Sacramento.
- The next public meeting for CalRecycle is on May 21, 2024.

4. IVRMA BUDGET 2024-25

Ms. Galarza provided the following updates.

- The previous meeting asked for a recommended percentage that would qualify for membership dues funding. It was found that 30% of the 375,000 qualified under the state funding. Ms. Galaraza provided more details as seen in the attachment. (Refer to the Cost-share agreement chart on page 3 of the minutes).

5. IVRMA UPDATES

Ms. Leal provided the following updates.

- For May IVRMA will be holding 4 cleanup events in the following cities Seeley (May 4, 2024), Calipatria (May 11, 2024), Niland (May 18, 2024), and Heber (May 25, 2024).
- For May 22, 2024, a Recycling presentation is scheduled for the Heber site.
- For June IVRMA outreach department will continue to visit businesses to do outreach on the Used oil, Used tires, and VSQG programs.
- For June, no clean-up events were scheduled.
- For July 13 there's only one clean-up event in the City of Westmorland.

6. MEMBER ROUNDTABLE

- Ms. Cordero thanked Mr. Pacheco and Mr. Mireles for their participation in the food scrap buckets for the Imperial Museum event. The City of Imperial presented the Service Agreement with IVRMA with IV Foodbank was approved. The donation for the reimbursement of the delivery lift gate was approved.
- Mr. Campos mentioned The City of El Centro will have a Ribbon-Cutting Ceremony for the South Imperial Avenue Extension Phase I and Phase II Projects at 9 a.m. on May 22, at the southeast corner of South Imperial and Wake Avenues. Everyone is welcome to attend.


